

Maryland Local Behavioral Health Authorities

Each Maryland jurisdiction has a Local Behavioral Health Authority (LBHA) which is responsible for planning, managing, and monitoring publicly funded mental health and substance use disorder services within its designated county or region. The LBHA serves as the first point of contact for residents seeking these public services and works with community partners to ensure quality, accessible, and comprehensive services for all people. In some jurisdictions, these duties may be split among multiple agencies with one acting as the Core Service Agency and the other as the Local Addictions Authority.
